Terms and Conditions of Event Bookings

Rates & Discounts

The BDNG will make the final decision of the type of registration and the fee that applies. Any registration type and fee may be adjusted by the BDNG after registration, at their discretion.

Any discounts offered are not transferable from the original recipient(s) of the offer, unless confirmed in writing by the BDNG.

Discounts may not be combined nor applied retrospectively.

Cancellations & Postponement

Cancellation by the delegate

Cancellations must be made in writing at least 30 working days before the event and may be subject to a cancellation fee.

No refunds will be made for cancellations within 30 days of an event and after this time and the full fee will be payable/retained.

You should obtain confirmation of your cancellation from the organisers for verification purposes.

Substituting one delegate for a colleague can be made.

A refund may be available at the discretion of the organisers for exceptional situations.

Event postponement or cancellation

If a Force Majeure event occurs or in the reasonable judgement of the BDNG the event is not going to effective, the BDNG may:

Provide the event online, either live or on-demand

Postpone the event to a later date

Cancel the event

'Force Majeure Event' includes but not limited to natural disasters, fire, flood, war or threat of war, acts or threats of terrorism, civil disorder, unauthorised strikes, governmental regulation, recognised health threats as determined by Government or any other matter or cause beyond the control of the BDNG.

Programme

The BDNG may alter the content, timing or speakers of the programme, after publication, without notice.

Some parts of the event may be provided by third-party partners and are therefore subject to variation and supply beyond our control.

Booking confirmation

Delegates will always be sent an email confirming a booking. Places are not guaranteed until the delegate receives this email.

Payment

Delegates must pay the registration fee prior to the event. Bookings received less than two weeks before the event and onsite can only be paid by credit/debit card.

If payment has not been received within this timeframe, the booking will be cancelled.

Use of data

The personal information provided by you will be held securely for the purpose of fulfilling the requirements of the event. Data is retained for a period of 1 year in order to verify attendance and produce a certificate, if requested.
